With reference to the 2<sup>nd</sup> round of counselling held on 12.10.2017 in the H.P. The above mentioned candidates have been recommended for admission provisionally by the Counselling Committee for which the admission letters to the said candidates have been issued on the day of counselling and the candidates have given time to report for admission on 16.10.2017 at 10.00 am in the respective college, failing which the claim for admission shall stand forfeited.

3. The original application Form along with relevant documents of each candidates recommended for admission under reference are being sent herewith for your ready reference and record.

4. It may kindly be noted that the candidates who do not report for admission on 16.10.2017, the necessary intimation to this effect along with category-wise list of candidates so admitted may be sent to this office immediately in order to fill up the vacant seats from the wait listed candidates.

5. It may also be ensured that before admitting the candidates, the final eligibility of each candidates must be checked /verified as per provisions of the prospectus and the discrepancy(ies) as pointed out by the Counselling Committee on the admission Form/ letter issued to the candidates during the course of counseling should have also been got settled. However, the relevant documents wherever required as per provisions of the prospectus may also be obtained from the concerned candidates accordingly.

6. The candidates who have passed their 10+2 examination other than HP Board of School Education Dharamshala/CBSE/ICSE, the equivalence certificate to this effect may be obtained from such candidates.
