Subject: Regarding admission to MBBS/BDS courses for the academic session 2017-18.

Sir/Madam,

In pursuance to the MOP up round of counselling held w.e.f 29.8.2017 in the H.P. University Auditorium, Summer Hill, Shimla-5, I am directed to sponsor the candidates college-wise as well as category-wise by way of shifting or from the waiting list against the vacant /resultant seats in order of merit-cum-choice of the colleges as per merit list drawn by the University on the basis of NEET-UG-2017 and the list of the candidates is enclosed at **Annexure-A** on the recommendations of the Centralized Counselling Committee headed by the Joint Director, Medical Education & Research, H.P. Shimla for provisional admissions to MBBS/BDS courses for the academe session 2017-18 in the respective colleges against State Quota/ Paid seats, as the case, may be. However, the recommendations of the candidates for admission to the aforesaid courses is provisional and subject to removal of discrepancy(ies), if any, as pointed out at the time of counselling by the Counselling Committee which have been marked on the Counselling forms as well as intimated to the candidates on their admission letters of the candidate(s) concerned. The admission is further subject to fulfilment of eligibility criteria and medical fitness as well as completion of all pre-admission requirements as per provisions of the prospectus. **In the case of Paid Seats in Govt. Medical Colleges and H.P. Govt. Dental College, Shimla, the candidates those deposited the requisite amount of 50% tuition fee during the counselling have been allotted seats only as per provision VIII.7(b) of the prospectus.**

2. The candidates as recommended for admissions to MBBS/BDS courses have been informed in writing by issuing admission letters during the counselling process with a copy endorsed to you to report to their respective colleges for completing the pre-admission requirement as per provisions of the prospectus along with remittance of fee **on 30.8.2017**, failing which their claim for admission shall stand forfeited/cancelled. The fee of candidates shifted from one college to another may be transferred by RTGS/Cheque to the Account of the Principals of new allotted colleges concerned .

3. The original application Forms along with relevant documents of each candidates as recommended afresh from the waiting list for admission under letter reference have already been handed over to the representative of the colleges concerned along with list of the candidates for your ready reference and record. However, the candidates who have been shifted from one college to another as mentioned above, their original Application Forms with relevant documents are required to

be sent by the Principals of the concerned colleges to the Principals of the new allotted colleges through Speed-Post or by deputing special messenger in order to reach the same within admission process ;under intimation to the University. But, their counselling proforma in original have already been sent to you.

4. The candidates who do not report for admission on the due date as mentioned above, necessary intimation to this effect along with complete updated list of admitted candidates (category-wise) be sent through e-mail on 30.8.2017 upto 5 P.M. to the **Assistant Registrar(Ent.Tests) H.P. University Shimla-5 only in order to fill up the vacant seats, if any on31.8.2017.** The candidates those not admitted their admission forms may also be returned to the University. Keeping in view the last closing date of admission i.e. 31.8.2017, the concerned staff may kindly be instructed to remain in touch with the admission process with the University and if any, drop-out of seat(s) the same may be intimated at once on same day to the University.

5. It may kindly be ensured that before admitting the candidates, the final eligibility of each candidate must be checked/ verified strictly as per the provisions IV.(A) 1 to 4 at pages 16 -19 of the prospectus and the discrepancy so pointed out by the counselling committee during the course of counselling should have also been got settled. The H.P. bonafide/domicile and other reserved categories certificate(s) as well as attested photo-copies of relevant documents wherever required as per provisions of the prospectus may also be obtained from the concerned candidates. The photograph & signatures of the above candidates including the candidates already admitted during the first round of counselling may kindly be verified/matched with the images of photographs, signatures and addresses of NEET-UG-2017 as per CD sent by the Director Medical Education & Research, H.P.

6. The candidates who have passed their 10+2 examination other than HP Board of School Education, Dharamshala/ CBSE/ICSE, the equivalence certificate to this effect may be obtained from such candidates.
