In view thereof, the 1st round of counselling for admission to MBBS/BDS courses for the academic session 2017-18 has been fixed as per revised schedule given below:-

The arrangement of stay during the counselling be made at the colleges level.

Besides, the Principals of the H.P.Govt.Dental College and the Private Dental Colleges may make arrangement to collect the fee amount on the day of counselling as per provisions VIII.7(a) & (b) of the prospectus. Further, the private dental colleges may also bring with them the complete details of other charges other than tuition fee being chargeable from the candidates on the day of counselling in order to inform the candidates accordingly before allotment of seats.
